1. Introduction

Good Will Children Private School (GWCPS) is committed to ensuring the safety, security, and wellbeing of all students during transportation to and from school, as well as for school-related activities. This policy aligns with the Abu Dhabi Department of Education and Knowledge (ADEK) regulations and the Integrated Transport Centre (ITC) requirements.

The aim is to provide a safe, high-quality, and efficient school transportation system, while clearly outlining the responsibilities of all stakeholders – the school, transport operators, staff, parents, and students.

2. Purpose

- To safeguard students during school transportation.
- To define the roles and responsibilities of school transport staff, parents, and operators.
- To ensure compliance with ITC and ADEK requirements.
- To regulate student behaviour, parental cooperation, and school accountability regarding transport.

3. Scope of Policy

- Applies to all GWCPS school buses, drivers, bus supervisors, transport coordinators, students, parents, and third-party transport providers.
- In case of conflict between ADEK and ITC regulations, ITC policies prevail.

4. Key Definitions

- School Bus: Vehicle licensed by ITC for student transportation.
- Driver: Licensed and trained individual responsible for safe operation of the school bus.
- Bus Supervisor: Licensed individual responsible for student safety during journeys.

- School Transport Coordinator: School-appointed staff responsible for monitoring daily transport operations.
- Pick-Up Point / Drop-Off Point: Designated safe locations for student handover.
- Non-School Transport: Scooters, bicycles, private vehicles, or other modes not under school supervision.

5. Policy Guidelines

5.1 Provision of School Bus Service and Student Safety

- GWCPS provides bus services in compliance with ITC regulations.
- Students with additional learning needs will be provided with necessary support to access safe transport.
- Student safety is the school's ultimate responsibility, regardless of whether services are managed internally or outsourced.
- Students will receive mandatory bus and pedestrian safety training.
- Student discipline policy applies to buses buses are considered an extension of the school environment.

5.2 Journey Duration, Pick-Up & Drop-Off

- Maximum journey time: 60 minutes (unless parents sign an undertaking for longer routes).
- Pick-up/drop-off must occur only at designated points.
- Younger students (below 11 years) must be handed over to an adult or a responsible sibling (≥15 years, with parental consent).

5.3 Exclusive Use of School Buses

• School buses may not be used to transport anyone other than enrolled students.

5.4 School Bus Fees

- Fees are set by ITC and approved by ADEK.
- Any exceptional increases must be pre-approved by ADEK.

5.5 School-Owned Buses

- Must meet ITC specifications for safety, maintenance, and record keeping.
- Regular inspections and records will be maintained.

5.6 Non-School Bus Transport

- GWCPS is not responsible for students who travel by non-school transport (private car, bicycle, scooter, etc.) until they enter school premises.
- Parents must sign a Non-School Transport Consent Form.
- Regulations:
 - Scooters/e-scooters: Allowed only for students aged 16+, speed ≤20km/h, on cycling paths.
 - Bicycles: Allowed with adult supervision for students under 12.

5.7 Field Trips & School Activities

Only ITC-approved vehicles can be used.

- Journey time restriction (60 minutes) does not apply.
- Vehicles must comply with speed and safety regulations.

5.8 Grievances and Complaints

- Parents may raise concerns regarding transport through the School Transport Coordinator.
- Final decision rests with the Principal, prioritizing student safety over convenience.

5.9 Parking & School Zone Speed Limits

- GWCPS will provide designated parking for buses and staff.
- All vehicles must follow Abu Dhabi Police school zone speed limits.

6. Transport Staff Requirements

6.1 Drivers

- Must hold QCC license + ITC license.
- Must be trained in ADEK Student Protection Policy.
- Must be registered on UAE PASS.
- Must report incidents to the Transport Coordinator.

6.2 Bus Supervisors

- Required for all buses transporting students ≤11 years.
- Must be licensed by QCC + ITC.
- Only female supervisors for KG/Primary and mixed buses.

- Must be trained in ADEK Student Protection Policy.
- Must register on UAE PASS.

6.3 School Transport Coordinator

- Appointed staff member.
- Primary contact for parents and ITC.
- Handles delays (fog, accidents), emergency changes, and system-wide issues.

7. Communication Protocols

• Bus Supervisors must:

- Inform parents of bus delays.
- o Notify school if parent/adult is absent at drop-off.
- Report student misconduct.

Drivers must:

o Report incidents and unsafe behaviour to the Transport Coordinator.

• Transport Coordinator must:

o Share updates with parents about delays, emergencies, or changes.
